PROSPECTUS FOR 2023-2024

The six months course envisaged under the Multi Purpose Health Worker scheme by the Ministry of Health, Government of India is to enable the Auxiliary Nurse Midwife (ANM) / Multi Purpose Health Workers (MPHW-F) to take up supervisory responsibility as a Female Health Supervisor (Lady Health Visitor) at the respective positions in the rural/urban health set up.

Eligibility:

Candidate should have registered herself in the State Nursing Council as an Auxiliary Nurse Midwife/Multi Purpose Health Worker and should have completed 5 years of experience as ANM/MPHW-F.

Minimum Educational & Professional Qualification:

- 1. 10th Std or Plus two (+2) pass
- 2. Certificate of MPHW(F) Health Worker/Auxiliary Nurse Midwife
- 3. Certificate of Registration from State Nursing Council

Course content:

The curriculum is approved by Indian Nursing Council, New Delhi. The course will cover *Basic Health Science and Principles of Nursing* with specific reference to *Reproductive and Child Health, Control of Communicable Diseases, Environmental Health and Principles and Techniques of Middle Level Management in Health Care Services.* Practical experiences are provided in the Community and Hospital settings.

Promotional opportunity:

As per the Multipurpose Health Worker Scheme, the 6 months Health Visitors Course qualifies the Female Health Worker to take up the supervisory post as Health Supervisors Female (LHV) at rural/urban health set up.
