TERMS AND CONDITIONS FOR RECRUITMENT OF THE POST:

1. GIRH & FWT, Gandhigram reserves the right to fill up or to alter modify or cancel the entire process of recruitment without assigning any reason.
2. Any delay on postal reasons shall not be entertained.
3. The candidate should read all the instructions and particulars of the advertisement.
4. A separate application is to be submitted for each post. Hard copy of self-attested certificates in sequential order of 10th, +2, UG and PG, Ph.D. & etc., testimonials and other documents must be sent along with the application.
5. Application costs Rs.1,000/- Demand Draft Drawn in favour of "The Director, GIRH & FWT" should be sent along with an application.
6. Application without Demand Draft will not be considered.
7. E-mail ID and mobile phone number should be mentioned in the application. All the communications will be sent through e-mail and Post.
8. Only shortlisted eligible candidates will be called to attend the interview. The Interview call letters will be sent via email and post.
9. Applications which are not in conformity with the requirement or which are received after due date will be rejected. If the post applied for is not indicated on the top of the envelope & the application, the same will not be entertained.
10. Canvassing in any form will be treated as a disqualification.
11. Candidates applying for position for S. No. 2 must submit the essential certificates to avoid disqualification. Strict compliance with this requirement is necessary to ensure a smooth recruitment process.

12. Fixed-Term Employment for Positions Listed Under S. No. 1 & 2:

The positions listed under S. No. 1 and 2 are purely on a fixed-term basis. The tenure of these positions shall be up to three (3) years. Selected candidates will be engaged on a fixed-term contract and will receive a consolidated remuneration of Rs.75,000/- per month throughout the tenure of the appointment.

13. Salary for Positions (S. No. 3 & 4):

Candidates selected for the positions listed under S. Nos. 3 & 4 will receive a consolidated salary of Rs.40,000/- (Rs.31,200/- as Pay and Rs.8,800/- as Special Allowance) per month for a period of one year. Upon successful completion of one year of service without any adverse remarks, the candidates will be placed on the designated pay scale PB1,19500 - 62000, Level – 8 and will continue on probation for a total period of two years, inclusive of the first year of service.

14. Salary for Positions (S. No. 5 & 6):

Candidates selected for the positions listed under S. Nos. 5 & 6 will receive a consolidated salary of Rs.25,000/- (Rs.15,000/- as Pay and Rs.10,000/- as Special Allowance) per month for a period of one year. Upon successful completion of one year of service without any adverse remarks, the candidates will be placed on the designated pay scale PB1, 20600 - 65500 - Level 10 and will continue on probation for a total period of two years, inclusive of the first year of service.

15. The selected candidates will be expected to perform multi-disciplinary and multi-functional duties, including any tasks assigned by the competent authority from time to time, to support the effective functioning of the Institute.
